### **Coronavirus Raises Stakes for Health Ethics**

From the mid-1980s when ventilators came into common use, the Center for Practical Bioethics has helped patients, families, providers and policymakers make decisions about what ought to be done given what can be done.

Supported by the community, we've applied ethical analysis to help distraught parents decide whether to remove their child's life support after an accident. To help clinicians untangle treatment options when incapacitated patients had no one else to speak for them. To help officials consider the consequences of proposed policies.

#### **Public Health Ethics**

The coronavirus pandemic hasn't changed the work of clinical ethics. But it has raised the stakes. In normal times, clinical ethics emphasize providers' duty to focus on the needs of the individual patient. In pandemic times, public health ethics, which emphasize justice and the common good, take precedence. Public health ethics ask: How to provide the most benefit to the most people? For example:

- How to implement Crisis Standards of Care, which
  providers adopt when a public health event substantially
  impacts operations and normal standards cannot be
  maintained.
- How to provide nursing homes the evidence-based
   Advance Care Planning tools needed to discuss treatment preferences with residents and families, as well as guidance for end-of-life conversations when loved ones cannot be present at the bedside.
- How to help clinicians on the front lines needing help to cope with the *Moral Distress* they feel when asked to provide care that differs from what they perceive as ethically correct.

#### **Mission Forward**

By early March, we knew that CPB's mission – to raise and respond to ethical issues in health and healthcare – meant providing ethical guidance through the pandemic.

 Develop, curate and disseminate practical pandemic resources that policymakers and healthcare providers need to apply ethical principles to patient care in real time. - Work with local, regional and national leaders to ensure that ethical principles are embedded in plans to adequately test, trace and support individuals of all ethnic and socioeconomic backgrounds whose lives and families are impacted by COVID-19.
- Respond to urgent requests from providers and families for consultations on ethically complex cases.

### Erika Blacksher Named John B. Francis Chair in Bioethics **Tackling Issues Around Class, Race and Health in America**



The Center named Erika Blacksher, PhD, as the fourth John B. Francis Chair in Bioethics. Dr. Blacksher formally assumed her position on September 1, 2020. She succeeds Richard Payne, MD, who worked tirelessly throughout his career to eliminate racial disparities in end-of-life care and chronic pain. Dr. Payne died unexpectedly in 2019

having served as the Francis Chair for six years.

### **Population Health**

"Dr. Blacksher is an incredible population health scholar and bioethics researcher, whose contributions to the broader field of healthcare are critically important in this time of global health crisis," said John G. Carney, CPB President and CEO.

"She is a pioneer in the emerging field of population health ethics and has developed her skills and scholarship through the authentic lived experience of those she seeks to serve."

#### Return to Kansas City

Dr. Blacksher is leaving her faculty position at the Department of Bioethics and Humanities at the University Washington School of Medicine where she has spent the last decade writing, teaching and researching. Her current research examines ethics issues raised by health inequalities, population health policies and how to engage populations burdened by health disparities.

She and her husband Tom Knittel, an architect, have family and friends in Kansas City, where from 1998 to 2001 she served as deputy director of CPB's Community-State Partnership Initiative to Improve End-of-Life Care.

### 26<sup>th</sup> Annual Flanigan Lecture A Letter to My People: Whiteness **Amidst a Racial Reckoning** in America

The 2020 Flanigan Lecture, presented by incoming John B. Francis Chair, Erika Blacksher, PhD, on August 17, was the Center's first large-scale virtual event with more than 700 people registered.

Dr. Blacksher explored the concept of "whiteness," its intersection with social class, and its role in shaping people's practicalbioethics/videos lives and health prospects. Drawing on her own life story

as a first-generation high school graduate, she connected her journey to ideas about whiteness that we need to begin to understand and explore. The Center worked with Bobby Keys Media, Inc. to produce the lecture.

### Ronn Huff: HCA Ethics Champion **Welcomes Partnership**

Ronn Huff was a tennis pro director at a park facility in Nashville working on his master's degree in religious studies. Now, 15 years later, he's the Director of HCA Healthcare's Center for Clinical Ethics.

After grad school, Ronn joined HCA as a clinical ethics consultant and part-time educator for Nashville area HCA hospitals. In 2016, recognizing the need for expanded system-wide education and quality assurance, HCA named Ronn as director of its new clinical ethics department, responsible for ongoing clinical ethics committee education across the healthcare system's more than 180 hospitals.

### Supporting Clinical Ethics

"Clinical ethics has a crucial role in hospitals," said Ronn. "But it's almost entirely composed of volunteers who may not have much ethics training and are being asked to consult on complex cases. We felt they needed more support."

Ronn welcomes providing that support with resources from the Center for Practical Bioethics.

# "Learning that Ryan Pferdehirt [Director of Membership and Ethics Education] is available to assist with ethics committee training and policy development is a blessing to me," he said. "Good clinical ethics committees don't happen by accident or by just assembling smart people in a room. Planning and practice are incredibly important.

"I especially applaud the Center's work," he continued, "in developing an industry standard for advance directives. Thoughtfully designed directives are crucial because they touch so many people, and I haven't seen any resources that are better."

### **Improving Advance Directives**

The coronavirus pandemic has intensified Ronn's focus on improving advance directives.

"We haven't moved the needle on completing advance directives in decades," he said. "The coronavirus underscores the importance of identifying surrogates and having conversations earlier."

Ronn is excited about working with the Center to improve advance directives by adding more nuanced language that clarifies when and how they apply.

### **Linda Doolin Ward Retires**

When Linda Ward shuts down her computer on October 31, 2020, she will mark the official end of a 50-year career that began as a teacher and ended after more than 16 years as Executive Vice President/Chief Operating Officer of the Center for Practical Bioethics. Prior to joining CPB's staff, she served three years on the Board of Directors.

In addition to responsibilities in finance, planning, governance and resource development, Linda pioneered and expanded corporate and community-based Advance Care Planning education, which she will continue to offer on a consulting basis. The recipient of numerous awards for volunteer service and civic leadership, Linda looks forward to continued commitment to the causes she has championed throughout her life, along with extra time to spend with family.

"No one in the Center's history has devoted as much time and energy from both a board and staff perspective to the success of the Center's vision as Linda," said John Carney, President and CEO. "We are not just lucky for having worked with her, we are all better people for having done so."
