### HEADLINES FOR 2021 FINANCIAL PERFORMANCE

### (Based on Preliminary Results)

Preliminary financial performance for 2021 was positive with our net revenue, including other income, projected to be approximately \$67.6k.

### **REVENUE**

Preliminary actual 2021 revenue is projected to be \$1,565,732, which is unfavorable by (\$54k) to our plan. The largest revenue variances to budget are in the following categories:

- Program/Grants released from restrictions (\$20.6k). Grants funds released included \$152.5k for the Sunderland Foundation AI project. This project will continue in 2022 and has been funded primarily through a second Sunderland grant of \$160k. Additionally, the \$13.8k balance of funds remaining for the Advance Care Planning in African American Communities grant through Harman Foundation were released. The Center's work on this project was substantially completed in 2020. The 2021 budget included additional grant funds anticipated for the AI project and Population Health.
- Development Income \$26.9k. Donations exceeded our plan overall by approximately \$19k primarily due to the memorial contributions we received. Also, we received \$8.8k more than anticipated in Payroll Protection Funds.
- Fundraising (\$51.2k). Fundraising was behind plan because the fall event was not held. This variance of (\$75k) is offset by the \$23.8k positive variance for our successful Annual Event.
- Communications (\$11.6k). Communications revenue was behind plan due to a lower Caring Conversations/ TPOPP order volume than anticipated. This is possibly due to more online (free) access by consumers.

#### **EXPENSES**

Preliminary actual 2021 expenses are projected to be \$\$1,511,090 which are favorable to budget overall by approximately \$89.8k. The primary expenditure variances to budget are in the following categories:

- Salaries and Benefits under budget by \$55.5k. The primary reasons for this variance are the part-time positions that were not filled and lower than anticipated insurance expense for staff spouses that moved to Medicare, offset by the 457(b) variance due to the catch-up contribution and account performance.
- Travel and Transportation and Conferences, Conventions and Meetings under budget by \$20.7k in total. These variances occurred because anticipated travel did not happen. Additionally, events planned for the fall continued to be virtual events or were not held.

#### 2021 PRELIMINARY OPERATIONS

In November our forecast was for total net operating revenue of \$23k. Our revenue results were approximately \$8.4k favorable to our forecast primarily due to unanticipated memorial donations received. Additionally, our expenses were favorable to forecast by approximately \$34.8k primarily due to lower staffing expenses. Preliminary 2021 net unrestricted operating revenue over expenditures is projected to be \$54.6k. Combined with the other investment income primarily related to the Center's 457(b) plan, our net operating revenue over expenditures is projected to be \$67.6k. Our 2021 operating fund beginning net assets were \$4.4k. Our operating fund ending net assets are projected to increase to \$72k.

# POLICY

#### **GUIDANCE AND THOUGHT LEADERSHIP IN HEALTH ETHICS**

Our staff regularly provides local, regional, national and international thought leadership through media appearances, invited lectures and scholarly publications. In 2021, we served on multiple Kansas and Missouri task forces and technical groups advising on ethical principles in pandemic response and impact to minorities.

Our time-intensive response to near daily calls for help - from individuals in a health crisis to officials making important policy decisions – demonstrates our commitment to education, to promote and protect the interests of those whose voices have not been heard or heeded, and to the just delivery of healthcare.

#### **CIVIC ENGAGEMENT AND HEALTH EQUITY**

#### **ARTIFICIAL INTELLIGENCE IN HEALTHCARE**

A group of 20 leaders have joined CPB's Advisory Council for our Ethical AI Initiative guiding the deployment of a framework to design, develop, disseminate and implement new models that address bias and inequity in AI in healthcare. Subgroups are creating a curriculum and preparing to implement a pilot project seeking to protect diversity and involve underserved persons.

#### **EXPANDED CLINICAL SERVICES**

We custom-designed clinical ethics workshops for three new health systems in Nebraska and Louisiana

#### **ETHICS COMMITTEE** CONSORTIUM

CPB's Ethics Consortium services increased in 2021 with monthly webinars, ethics immersion workshops, the monthly Ethics Dispatch e-newsletter and ongoing access to case studies, guidelines and Crisis Standards of Care with staff support.



Improved Ethics Direct training services to 16 Affiliate Health Systems involving 42 locations, providing nearly 500 hours of direct clinical consultation

#### MEDICAL ETHICS EDUCATION

CPB renewed contracts with two of the three area medical schools for ethics training, education and mentoring of students in 2021. The renewals include 1.450 students from first-year medical schools and masters-level through residents and fellows involved in a variety of clinical ethical settings.



#### EDUCATIONAL RESOURCES

**Bioethics Library** of more than 4,000 reports and other resources made more easily accessible

The new PracticalBiothics.org website launched in November. overhauling our Bioethics Library that includes reports, guidelines, program materials, case studies, interviews, lectures and symposia.

The redesign will appeal to more diverse groups, making it easier to find resources, while allowing CPB to be more responsive to requests for content.

# **PROFESSIONAL EDUCATION AND CLINICAL SERVICES**

# Affiliate Agreements and Converting from Membership (Charitable model) to <u>Ethics Direct/Ethics Plus</u> (fee for service)

In 2020, we initiated a new earned income strategy based on formal agreements with healthcare providers to support, facilitate and improve performance of ethics committees as well as clinical staff involved in ethically complex cases. The primary work was a longitudinal approach converting the traditional group of "member hospitals" who agreed annually to support the work of the Center. We historically considered the monies received from those providers "unearned" and thus a "contribution" because there was no formal agreement defining the services or fees associated with those services. Membership was viewed by the health systems, in a number of instances, the same way that they supported community-based organizations. In any event, no formal value proposition was defined, and the support was often dependent solely on the institutional decision maker(s) and their relationship with the Center.

In 2020, we formally defined the sets of services and developed a fee model based on the size of the entity (self-reported gross billings and bed size). We then began approaching each of the health systems and "members," engaging in discussion about converting to a service model to participate in a set of basic services provided to all Ethics Committee Consortium members with an add-on optional service to purchase clinical ethics consultation services directly from the Center at an hourly rate (with a volume purchase discount). The goal for both was to improve their competencies and services internally and for the Center to secure a more sustainable stream of revenue for our ethics services.

In 2021, we expanded this strategic priority by hiring an additional staff member, Polo Camacho, PhD, as Program Manager and Health Ethics Education Promoter to work with our Clinical Ethicist, Ryan Pferdehirt, whose primary duties were to spend half his time working in delivering these services, including efforts to directly provide clinical consultation services to hospitals seeking this assistance from the Center. The additional service was named Ethics Plus. As we enter into 2022, we now have three systems utilizing Ethics Plus in addition to a subcontract from the University of Kansas Health System to support Dr. Terry Rosell's work in leading the Ethics Committee work for the health system.

Dr. Camacho's responsibilities include managing the service delivery of what we call "Basic" ethics services, ensuring that the providers are informed of and benefit from the defined set of support training and resources that cover such things as the monthly electronic newsletter for Ethics Committee members and regularly scheduled webinars and other training on timely issues (e.g., caring for unvaccinated, difficult cases, advance care planning, ethics policy guidance on the responsibilities of ethics committees within a health system). Within the last two years, additional training and resources – particularly those involved with the pandemic – have been offered to support ethics committee volunteers and committees in their work and their hospital's response related to issues such as crisis standards of care.

As of December 31, 2021, there are 16 signed Affiliate agreements, including two for Ethics Plus, in place with another confirmed to come online in early 2022. Basic service agreements are also being marketed to new entities. We have expanded services beyond hospitals to include home health and hospice agencies and organ procurement organizations providing services at 42 facilities. Delivering ethics services to these varied facilities involves frequent onsite availability and remote education for leaders involved in Ethics Committee work.

# Ethics Committee Consortium (ECC)

Wrapping up its 35<sup>th</sup> year as the nation's oldest continuously operating consortium of its kind, Ethics Committee Consortium membership includes 40 institutional ethics committees involving more than 500 individual members. Benefits for ECC affiliate organizations, as well as individual members of our Sustainers Council (see Monthly Donor item below), include:

**Medical Ethics Immersion Workshop Series** – Presented by Ryan Pferdehirt, D. Bioethics, HEC-C, in four onehour lunchtime sessions, the Immersion Series is designed to help ECC members develop a robust understanding of basic biomedical ethics. An average of 60 people registered for each session. Each session was archived for asynchronous learning. Evaluation survey responses rated all aspects of the following elements very good to excellent:

- Introduction to Ethical Decision Making (October 14)
- A History of Ethical Foundation of Clinical Practice & Seminal Cases (October 28)
- Approaches to Clinical Ethics and Consultation (November 4)
- Role, Structure and Value of Clinical Ethics Committees and Consults (November 11)

**Ethics Dispatch** – ECC members received the monthly *Ethics Dispatch*. Written by Center staff, each edition offers guidance on a "hot topic" impacting providers, a case study for illustration, and "Ethical Musings" by the author. Each edition includes web links to recent news stories relevant to ethics committees. ECCs report using the Ethics Dispatch to supplement educational programming.

# **Medical Ethics Workshops**

In 2021, we introduced clinical ethics workshops – virtual and in person – in response to requests from providers seeking introductory training for their staff. Workshops typically include an introduction to ethical decision making and cover such topics as the consultation process, conversational techniques, complications in challenging ethical situations, and EMRs and charting. In 2021, we provided custom-designed workshops to the following groups:

# **Medical Student Education**

We continued our long-term contractual teaching relationships with the **University of Kansas Medical Center (KUMC)** and **Kansas City University (KCU)**.

KUMC in collaboration with The University of Kansas Health System, renewed its contract with the Center for the 13<sup>th</sup> consecutive year for part-time faculty services of Dr. Tarris Rosell, Rosemary Flanigan Chair. We also secured an additional \$25K per year as part of the renewal (2021 and 2022). Key accomplishments of 2021 include:

- Oversight of the hospital clinical ethics consultation service, which provided more than 150 complex ethics consultations
- Serving as ethics faculty for many dozens of case conferences with medical students, residency and fellowship programs
- Providing a weekly clinical ethics orientation session for physician residents
- Co-chairing the Hospital Ethics Committee
- Providing ethics consultation for the Heart Transplant program and the Blood and Marrow Transplant team and serving on the Donor Advisory Council
- Serving on the health system Pandemic Triage Team for development and potential implementation of crisis allocation guidelines
- Co-directing the Clendening Summer Fellowship program, a competitive stipend research opportunity and course for 10 medical students
- Mentoring projects of student researchers in the medical humanities

KCU renewed a contract with the Center for the 8<sup>th</sup> consecutive year for part-time faculty services, fulfilled in 2021 primarily by Dr. Ryan Pferdehirt, Director of Membership and Ethics Education, for half his time. We secured a small increase in the rate. Key accomplishments include:

- Providing and mentoring a one-month clinical ethics rotation for a KCU medical student
- Mentoring a group of KCU students attending (virtually) the annual conference of the American Society of Bioethics and Humanities
- Collaboration with KCU on the Center's annual Flanigan Lecture, with a panel of 5 alums of the dual degree program—DO and MA in Bioethics—discussing ethics issues encountered in their first decade of medical practice and especially during the COVID pandemic
- Teaching 5 courses (Bioethics I and II, Clinical Consultations, History and Methodology of Bioethics, and Clinical Dilemmas)
- Supervising "<u>Bioethics Bowl</u>"
- Serving on the <u>KCU Institutional Review Board</u> (IRB)

# **COMMUNITY EDUCATION AND ENGAGEMENT**

# 27<sup>th</sup> Annual Flanigan Lecture – <u>Young Physicians on the Frontline: Real-World Perspectives on Healthcare</u>

and Ethics During COVID and Beyond -- Five physician-ethicists who were part of the 2008 inaugural class of Kansas City University's dual degree DO/MA in Bioethics program reflected on their practice of medicine and ethics during COVID and beyond. Common themes of the discussion, led by Flanigan Chair Dr. Tarris Rosell, included management of grief, patient autonomy vs. common good, exhaustion and the duty to serve, and the escalating impact of moral injury. Annual Event – Humility, Health and Healing: Where Do We Go from Here? – Faced with planning the 2021 event at the height of the pandemic, we opted for a private broadcast (i.e., virtual format) produced by Eventology and co-chaired by Debbie Sosland-Edelman and Alan Edelman. With the Nelson-Atkins Museum of Art as the backdrop, the broadcast aired on February 25, featuring the Dalai Lama's personal physician, Dr. Barry Kerzin, and presentation of the Vision to Action Award to Dr. Steven Stites. Despite pandemic restrictions, we raised \$151,873 in net revenue.

**Berkley Symposium – Cultivating Resilience, Compassion and Mindfulness** – On March 12, Dr. Barry Kerzin followed up his Annual Event keynote address with a two-hour workshop designed especially for frontline healthcare workers underwritten by CPB donors that garnered more than 700 registrations. Dr. Kerzin provided practical tools for coping with the stressful demands of the COVID-19 pandemic. All four segments are available on CPB's YouTube channel – <u>Mindfulness, Emotional Hygiene, Compassion and Meditation.</u>

Vaccine Webinar Series – The Center presented a four-part Vaccine Webinar Series to address many of the safety, accessibility and hesitancy issues surrounding the development and distribution of COVID-19 vaccines.

# **POLICY AND PERSONAL GUIDANCE**

The Center responds to calls for help daily, from patients and family members to organizational leaders and official policymakers. For example:

- **PERSONAL GUIDANCE** Distraught adult daughter calls the Center about her confused but still independent mom experiencing bouts of paranoia and anxiety caused by dementia. The daughter respected her mom's autonomy but struggled with being accused by her mother of stealing from her. Resources in their rural community were limited. We helped the daughter develop a plan and set priorities to ensure her mom's dignity.
- **POLICY GUIDANCE** We are called upon by healthcare administrators, public health and elected officials to bring ethical perspective to protocols, standards, executive orders, regulations and even legislation. In addition to responding to individual requests for guidance, CEO John Carney and others on our staff served on committees and collaborated with more than three dozen local, regional and national entities.

This time-intensive work, for which we receive no regular financial support, reflects our commitment to promote and protect the interests of those whose voices have not been heard or heeded, to education, and to the equitable and just delivery of healthcare.

# **EDUCATIONAL RESOURCE LIBRARY**

The launch of our new website on November 1 included a complete overhaul of our Bioethics Library of more than 4,000 reports, guidelines, briefs, program resources, case studies, interviews, lectures and symposia. The new website was designed to appeal to our diverse constituencies and make it easier for users to find what they're looking for. It will also provide CPB with more direct control over design and content.

Audio, video and PDF files are now fully searchable in the following eight bioethics categories: Advance Care Planning, Biotechnologies and Genomics, End of Life Ethics, Informed Consent, Patient/Physician Relationships, Pediatrics, Public and Population Health, and Resource Allocation. <u>https://www.practicalbioethics.org/resources/</u>

# 2. ADVANCE CARE PLANNING and SHARED DECISION MAKING

The Center's Advance Care Planning programs continue to build on its legacy work in end-of-life care, with emphasis on diverse communities' participation in advance care planning.

# Advance Care Planning (Caring Conversations®) Community Education

This activity encompasses advance care planning programs and resources – including *Introduction to Caring Conversations* ® and the *Caring Conversations* ® *Workbook* in English and Spanish – available to the general public and employers.

**Online Workshops for General Audiences** – While instigated by pandemic precautions, virtual workshops proved to be a most efficient and effective means to reach the most people with the most impact. A total of 430 people registered for 4 workshops held in the spring and 4 in the fall, with 198 attending live. Each workshop provides guidance through the advance care planning process, including suggestions for discussing wishes, values and healthcare preferences with loved ones, naming an agent, and forms for documenting this information. <u>View workshop</u>.

**Employee Benefit Program Services** – The Center has agreements with Hallmark (12<sup>th</sup> year) and Evergy (4<sup>th</sup> year) to provide advance care planning education and resources for employees and family members. In addition to online workshops, these agreements include additional services:

- 24/7 availability of a clinical ethicist on our staff to provide guidance in a healthcare crisis
- Customized Caring Conversations® workshops
- Free Caring Conversations<sup>®</sup> materials, including TPOPP (Transportable Physician Orders for Patient Preferences)
- Help completing Advance Directives and Durable Power of Attorney for Healthcare forms

<u>Caring Conversations® Resources</u> – We had more than 51,000 interactions involving Caring Conversations resources, and 22,400 involving TPOPP resources.

# Transportable Physician Orders for Patient Preferences (TPOPP)

TPOPP is the Kansas and Missouri version of POLST. POLST (Physician Orders for Life-Sustaining Treatment) is a voluntary national program that seeks to better align treatment plans with goals and values of frail and seriously ill patients with life-limiting illness. Under POLST, more than 45 states have adopted standardized medical order sets for such patients. These actionable medical orders follow patients across care settings. The KS/MO initiative, sponsored by the Center, is the country's only bi-state initiative. TPOPP depends on extensive participation and coordination among and between providers and care settings (e.g., hospitals, long-term care, EMS, etc.) for successful implementation. Thousands of TPOPP orders are executed by patients and families throughout the two-state region from Sabetha in southwest Kansas to St. Louis in east central Missouri. In 2009, the Center began this initiative by implementing a pilot program in Topeka and has been training KS/MO providers at various stages of development of TPOPP coalitions since that time. In 2021, we distributed 22,250 TPOPP forms to providers and 150 copies of *Caring Conversations @...continued* to consumers.

# Advance Care Planning in African American Faith Communities

In 2015, based on the conviction that advance care planning (ACP) promotion must be rooted in the context of the cultural and spiritual life of African American communities, the Center developed an initiative to design and implement a replicable program with influential African American faith communities to improve ACP and end-of-life treatment for African Americans. Our early work revealed that churches need specific curriculum and logistical support to undertake ACP promotion within their congregations. This led to five one-day inperson and/or virtual events (Alameda, CA, Boston, MA, Kansas City, MO, Pittsburgh, PA, and Columbia, SC) being held in 2020-2021 using a variety of updated curricula to teach the basics of ACP, palliative care and hospice to African American pastors, congregations and community organizations. These educational events were well attended, and survey responses indicate that the workshops were well received with most respondents increasing their understanding of ACP, as well as their confidence and readiness for specific ACP milestones.

In late 2021, this project transitioned to Duke Divinity School, where they plan to preserve and disseminate the work already done and to extend the trajectory of that work going forward, both to reduce racial disparities in ACP and to continue nurturing the capacity of the African American Advance Care Planning/Palliative Care Network to lead efforts to overcome racial inequities across healthcare, all in a way that honors the legacy of Dr. Richard Payne, a singular witness for healing and justice with respect to African American health.

# 3. HEALTH JUSTICE THROUGH SYSTEMS CHANGE

**COVID-19** – The Center's response to the pandemic evolved in 2021 with the trajectory of the pandemic, with a strong emphasis on vaccine allocation, access and hesitancy. More than 530 people participated in our four-part Vaccine Webinar Series, "The COVID VACCINE: State of the Science and Ethics of Equitable Allocation," featuring national and local expert panelists:

- Safety & Efficacy in Emergency Authorization: Getting it to those who want it, responding to those who don't (January 29)
- Equitable Distribution Logistics, Resistance and Justice (March 5)
- The Impact of Vaccination on Lives and Livelihoods: A People's Dialogue (April 1), in partnership with American Public Square
- COVID Vaccine Access in the Latino/x Community: Building Trust, Promoting Public Health (August 14)

We continued to collaborate with local, regional and national entities to advocate for inclusion of ethical principles into pandemic policies and plans. CEO John Carney alone worked with more than two dozen outside organizations in 2021 serving on regional pandemic response and state tasks forces devoted primarily to improving access to underserved populations.

**Ethical** AI – The goal of the *Ethical* AI Initiative is to deploy a framework for design, development, dissemination and implementation of AI models for healthcare that protect diversity and inclusion while systematically reducing risk for bias. In 2021, we established an interdisciplinary and intersectional 20-member Advisory Council and a Community Action Work Group to engage diverse populations and marginalized communities. Work began on the development of an AI ethics curriculum and identification of a pilot project to test the curriculum. In the near term, the project will finalize the ethical framework for AI in healthcare. Long-term goals envision development of consultation and certification services for healthcare IT practitioners and providers.

**Civic Engagement and Health Equity** – John B. Francis Chair, Erika Blacksher, PhD, is bringing her expertise in population health and democratic deliberation to expand CPB's longstanding commitment to health ethics. Four activities illustrate her national leadership in these areas.

# Building a Circuit of Civic Learning, Dialogue and Connection to Advance Health Equity:

<u>A Deliberative Approach</u> – In September 2021, County Health Rankings & Roadmaps, a program directed at the University of Wisconsin Population Health Institute with support from the Robert Wood Johnson Foundation, awarded \$87,874 to fund the foundational phase of this new project, led by Dr. Blacksher. In collaboration with a seasoned research team and guided by a 15-member committee of local, regional and national experts in population health sciences, democratic deliberation, intersectionality and health justice, they are building a toolkit to convene racially, socioeconomically and geographically diverse Kansans and Missourians in a bi-state initiative to learn about, discuss and weigh in on pressing population health challenges.

<u>Civic Engagement and Civic Infrastructure to Advance Health Equity Workshop</u> – Dr. Blacksher served on a National Academies of Science, Engineering and Medicine committee that planned a two-day virtual workshop to explore the relationships between civic and political engagement and health equity and a more inclusive democracy. The workshop aired June 14-15, 2021, with some 500 people participating. A subset of attendees also participated in a mini-deliberation designed and facilitated by Dr. Blacksher. They weighed in on the question, "Which civic infrastructure investments are most important in advancing health equity?" Dr. Blacksher authored an appendix to the final report describing its outcomes, which will soon be finalized.

# Public Deliberation Project of the New York Academy of Medicine and the New York City

**Department of Health** – As part of the project, Dr. Blacksher developed and delivered a presentation on various ways to think about distributive fairness that accompanied two scientific expert presentations about the COVID-19 pandemic. This online series of deliberations was held between December 2020 and January 2021 (three in English, two in Spanish), gathering informed input from a cross section of New Yorkers representing all NYC boroughs. The results of these deliberations informed New York City's vaccine distribution plan and were published in the peer review literature.

**Interdisciplinary Association of Population Health Science** – Dr. Blacksher is serving on the programming committee for the Association's 2022 conference, the nation's premier venue for population health science research and scholarship. The 2022 program will address "Interdisciplinary Approaches for Advancing Population Health Equity."

### **PAINS-KC**

Chronic pain continues to be a public health crisis, affecting more than 50 million Americans. The Center's PAINS-KC initiative, begun in 2013, gives voice to those who live with pain and provides a safe place for engagement, education and advocacy. While COVID restricted in-person gathering in 2021, Citizen Leaders met virtually and sustained collaborations with The Pain Community, the Alliance to Advance Comprehensive Integrative Pain Management, and other pain advocacy organizations.

# **HUMAN RESOURCES**

In 2021, the Center improved its staffing capacity with the addition of two new PhDs. This is the first time in the Center's history in which five staff members are credentialed with doctoral degrees. We welcomed **(Marco) Polo Camacho, PhD**, to the staff in July. Dr. Camacho manages TPOPP, Ethical AI and the Ethics Committee Consortium, promotes the Center's health ethics education services and expansion of our services to the Latino community and our bilingual capacity. **Lindsey Jarrett, PhD**, joined the staff full time in December as Principal Investigator and Program Director of the Ethical AI Initiative after having served the remainder of the year as a part-time consultant. **Matthew Pjecha, MS**, also served as a consultant to the Ethical AI project for half the year but is rejoining the staff part-time in 2022.

In September we contracted with **Megan Neher Public Relations** to help support digital marketing, social media and media/community relations aspects of our Integrated Fundraising, Marketing and Communications plan.

# **FUNDRAISING**

In 2021, we challenged ourselves with an ambitious seven-part Fund Development Plan. Despite the pandemic, the plan was largely successful in four categories: Individual gifts (Appeals), Board Giving, Events, and Foundation Grants. We fell short of our goals in Planned Giving, due primarily to our inability to gather face to face for events. The Center was awarded a \$158,000 loan from the PPP (Federal Pandemic response), which converted to a gift award to supplement the individual/foundation support we received.

Annual Event – We presented *Humility, Health & Healing, where do we go from here*? virtually on February 25. With the Nelson-Atkins Museum of Art as the backdrop, the private broadcast produced by Eventology began with a greeting from Debbie Sosland-Edelman and Alan Edelman, event co-chairs, Eva Karp, board chair, and Sandra Stites, immediate past board chair. After a welcome from CEO John Carney and Julian Zugazagoitia, director of the Nelson-Atkins, segments included:

- "Faces of Humility," a collage of images of clinicians treating COVID, patients and families illustrating dimensions of humility set to the music "God Bless the Child"
- Keynote Presentation, "Cultivating Resilience, Compassion and Mindfulness," by Dr. Barry Kerzin, the Dalai Lama's personal physician
- "Transformations" featured comments and insights from frontline healthcare workers.

The evening also included the opportunity to purchase tickets to win a "Silver Ticket Getaway" to Four Diamond Tubac Golf and Spa Resort, to participate in a drawing for a brooch/pendant, "Crossroads of Decision," custom-designed by Robyn Nichols, and respond to a Text to Give appeal.

We netted \$151,873 from gross revenue of \$234,302, making this our most profitable annual event.

Annual Campaign – The 2021 Annual Campaign, The Long March, included:

- Article in Practical Bioethics (print newsletter) mailed early October.
- Weekly emails in November/December to 7,100-member database featuring videos of 9 individuals (staff, student, community partners) describing a CPB program or service, briefly summarizing the need, goal and "your support makes this possible."



• Greeting card-style appeal mailed to 525 recipients on November 30, 2021.

The campaign raised a total of \$200,872, which included over \$20,000 in memorial donations from more than 80 donors following the November 26, 2021, death of our board member Liza Townsend. The year-end campaign proceeds also include a number of family foundations and trusts that historically support the general operations of the Center. Those donations represent about 75% of the remaining total. However, it is worthy to note that about 80 more individual contributions were received from our campaign, making this one of the most successful efforts in our history for year-end fundraising.

Major Gifts – We published *The Case for Practical Bioethics* and distributed it to major donors, civic and foundation leaders. John Carney met in person and/or virtually with approximately 10 donors over the course of a three-month period. Some meetings were cancelled due to the pandemic. The results were modest with about \$35,000 netted in the effort and one new donor asking for pledge information.

**Planned Giving** – We also drafted a Legacy Giving brochure. A scheduled in-person gathering at the home of Linda and Terry Ward in October was cancelled due to COVID. We are aware that the marketing window to a significant group of loyal but aging Center supporters will soon close and will pursue these opportunities vigorously in 2022.

**Sustainers Council & Legacy Society Update** – We introduced this quarterly enewsletter in March 2021 as a special benefit for monthly donors and those who have let us know of their plans for an estate gift to the Center.
