On June 24, 2022 the Supreme Court of the United States reversed the 1973 Roe v Wade court ruling that protected the right to abortion in the United States.In response to that reversal, the Center has released a statement in three parts: considerations, precepts, and recommendations.

America's Nursing Crisis: What Should Be Done?

We posed three questions leading up to the 28 th Annual Rosemary Flanigan Event on August 4, 2022:

- Is "crisis" an accurate description of what nurses and all of us currently are facing?
- If so, was this crisis preventable or inevitable given the pandemic?
- And, whatever this is, what should be done?

These and other questions were discussed by keynoter Dr. Karen Cox, President of Chamberlain University, and seven other nurse panelists with approximately 200 virtual

and in-person participants at Kansas City University.

Yes it's a crisis here in the U.S. and internationally. Probably it was inevitable, and the pandemic merely accentuated it. And indeed, there are actions that should be taken to ameliorate the current nursing crisis.
