
Get to Know James Stowe New President and CEO Will Focus on Health-Related Social Needs

Ethical Al Initiative Four Recommendations for Ethical Al in Healthcare

The Center's Ethical Al Initiative is developing interventions to mitigate problems and risks associated with the use of artificial intelligence and machine learning in healthcare. Until now, we've tended to provide guidance to those creating algorithms, while offering little support to every other stakeholder across the healthcare industry. The Ethical Al Initiative sees opportunities to examine decisions that are made regarding Al tools **before** they get to a data scientist's queue and **after** they are ready for production.

To our knowledge, this initiative is the only effort of its kind. 

Heeding Voices of the Unheard Berkley Symposium Offers Creative Responses to the Wishes of Elders

An attentive crowd gathered in the social hall at Village Shalom the morning of December 14 to explore how to become better listeners and to gain insight into the benefits of so doing.

Artists **Andy Newcom** and **Marn Jensen** described the impact of listening in more than 70 conversations they had with elders that resulted in works of art and accompanying narrative curated in their *Art of the Wish* exhibition.

SuEllen Fried traced the importance of listening in her decades of volunteer work, from raising awareness of the causes and impact of bullying in children to her involvement in groundbreaking programs for prisoners.

Janet Baker, executive director of Shepherd's Center Central, presented an overview of the organization's work to help both active and homebound adults lead healthy, engaged and independent lives.

Terry Rosell, Rosemary Flanigan Chair at the Center for Practical Bioethics, closed the morning with the moving story of his mother Donna Mae's journey from terminal diagnosis to death as an illustration of "narrative ethics" and the role that listening played in a "good ending" for her and her family.
