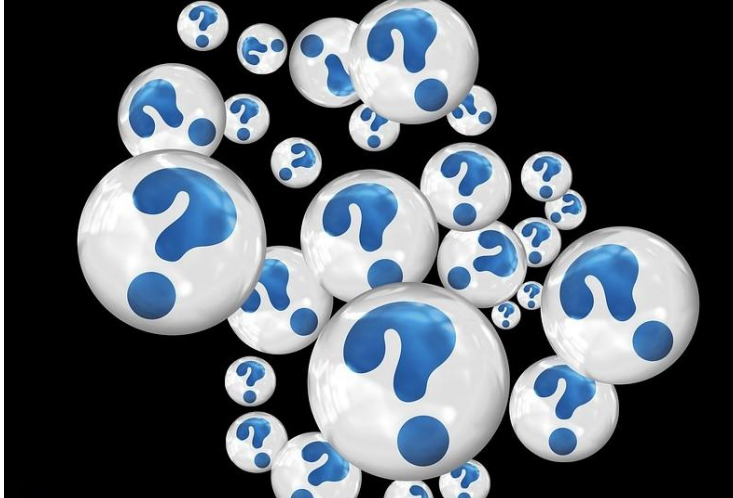

## New Benefits for Sustainers Council Members Another Good Reason to Become a Member

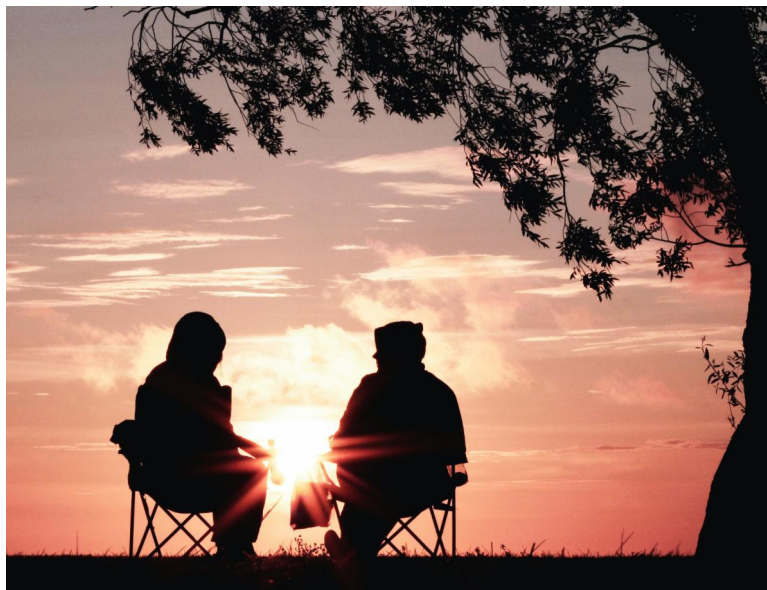
We're offering a new Sustainer Council benefit that's available to you too by becoming a monthly donor or as a member of our Legacy Society.

Have you thought about who will speak for you in a life-threatening situation if you can't speak for yourself?

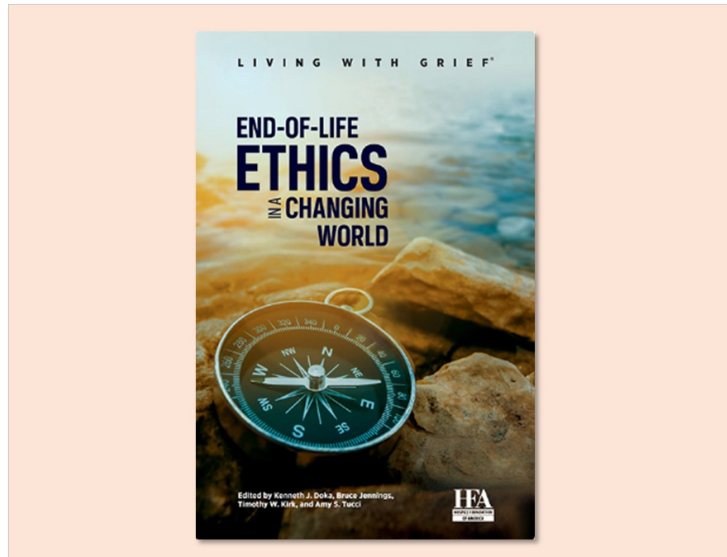
