### Clinical Ethics Corner Video Case Study Value of a Person: When Needs and Benefits Conflict

A patient was dying and likely to have viable organs for procurement, but the patient was in extreme pain and needed medication.

During a care meeting, the team discussed multiple options for alleviating the pain. But during the meeting, an OPO (Organ Procurement Organization) representative noted that if they were to administer a particular medication, it would make those organs less likely for successful procurement —and thus not able to give the gift of life to other patients.

Ryan Pferdehirt, VP of Bioethics, raises questions that should be asked in scenarios like this, where expectations to provide for others and who should make decisions are unclear.

# Are you a victim of enshiftification? Join The Center in Fighting Tech Platform Stranglehold on Small Nonprofits

Last year the Center needed to switch to a better Customer Relationship Management (CRM) platform.

First step was to download our data from the old CRM and import the data into the new CRM. As simple as it sounds, we couldn't download the data in any meaningful way without knowing code. The old company offered to do the export for a few thousand dollars. But it's our data, not theirs. We refused and paid a developer to do the conversion.

Our Communication and Website Coordinator, Monica Delles, explains why these types of demands are unaffordable and unreasonable, if not unethical, especially for small nonprofits like the Center...and what we're doing about it.

#### **Embracing the Intersection for Mental and Emotional Wellness**

As a means of providing mental and emotional support, apps are no different than churches, schools, hospitals, community centers, concert venues, and public parks, according to Lindsey Jarrett, PhD, VP of Ethical AI, in a piece she was requested to write by <u>i.c. stars</u> |\*, one of the Center's community partners.

Apps, she says, are just a slice of how we create things to build community and engage in our desire for belonging. All of which points to a gap that may not be filled with more technology, but possibly an evaluation of the intersection that now exists between technology and humans.

Lindsey concludes with questions to help us think about ways that we can act inside this gap to create mental and emotional wellness.
