

Ethics Dispatch Ethical Perspectives on Medicaid Cuts

With Medicaid cuts looming, Cassie's hot topic in the July Dispatch applies the principles of bioethics to the cuts' impact on rural healthcare. She concludes: "In towns like the one I grew up in – a town like many others – removing Medicaid could mean the collapse of half the healthcare system."

Going deeper in his ethical musings, Ryan explores the philosophical concept of "ought implies can," which holds that for someone to have a moral obligation, that person must have the ability to accomplish said obligation. Which begs the question: When do we have a moral obligation to provide Medicaid coverage?

Distributive Justice: A Challenge for Clinical Ethics

A patient in his early 40s recently came to

the U.S. to visit family and collapsed. He was taken to the hospital and received an early diagnosis of cancer. The patient is not a legal resident and does not have a "path to insurance"—not through Medicare, Medicaid, private insurance, or otherwise. The cost of treatment is well over \$5 million, though the hospital is unable to give an exact amount. Because of this, the patient cannot pay out of pocket.

With treatment, there is a 90% chance of full recovery. Without treatment, death is likely in the near future. The patient would like to pursue treatment.

Does this patient deserve to receive the treatment? What is justice?
